# Introducing our Keynote:

## Susannah Rowe

Susannah Rowe, M.D., M.P.H., is a high-risk cataract surgeon and Assistant Professor of Ophthalmology, as well as Vice Chair for Patient Safety and Quality for the Department of Ophthalmology, and Director of the Exceptional Vision Service at the Boston University School of Medicine. She earned degrees from the Johns Hopkins University School of Medicine and the Johns Hopkins School of Hygiene and Public Health, and subsequently trained in Ophthalmology at Harvard's Massachusetts Eye and Ear Infirmary. She completed the Robert Wood Johnson Clinical Scholars Program at UCLA, and the Clinical Effectiveness Program at Boston Children's Hospital. Her primary professional focus has always centered around defining, measuring, financing, and providing quality care for underserved populations.



Dr. Rowe serves as an Attending Ophthalmologist at Boston Medical Center, the South Boston Community Health Center, and the East Boston Neighborhood Health Center, where she provides consultative eye care, and teaches ophthalmic surgery to resident trainees. She specializes in high risk cataract surgery and ophthalmic surgery for patients with special needs. She especially enjoys working with patients, their families, and caregivers to provide ophthalmic care that improves quality of life and visual function.

Dr. Rowe is fluent in Spanish and speaks enough French and Portuguese to complete an eye exam. She is currently trying to learn phrases in Albanian and Moroccan Arabic to better serve her patients. She grew up in the Boston area and studied at local schools. She resides just outside of Boston with her family.

In addition to the keynote, Dr. Rowe will also be presenting a concurrent session "Visual Function and Quality of Life in People with Intellectual Disability".

## **“Ten Years and Counting: Lessons from a Decade of Successful Eye Surgery for People with Intellectual Disability”**

The Exceptional Vision Service (EVS) at Boston Medical Center was founded over a decade ago with the mission of increasing access to surgical eye care for people with intellectual disability. Over the last ten years, the EVS has cared for over 60 patients from all parts of Massachusetts, addressing myriad barriers to care and developing systems to provide safe, effective, comfortable surgery to restore eyesight to people whose lives are impacted by visual impairment. No patient with treatable eye disease has been turned away because they are “not a candidate” for eye surgery.

The keynote will review some of the most common barriers that our patients experience in obtaining needed eye care, and to present the solutions that we have developed in collaboration with our caregiver partners to address these challenges. We will cover how to know if an eye exam is needed, indications for surgery, anesthesia considerations, pre-operative and post-operative care, working with family and legal guardians, and collaboration with other health care providers.

### A. **Visual Function and Quality of Life in People with Intellectual Disability**

Presenter: Susannah Rowe, MD MPH  
Director, Exceptional Vision Service  
Vice Chair for Patient Safety and Quality  
Assistant Professor, Department of Ophthalmology  
Boston University School of Medicine

Description: Good vision is well-recognized as an important predictor of successful aging among typically abled people. The onset of visual disability has been associated with accelerated functional and cognitive declines; greater dependency on caregivers; worsening indicators of mental health; a greater risk of falls and fractures, and earlier death. Successful treatment of visual impairment has been shown to improve each of these health indicators.

Assessing visual function for people with intellectual disability requires a clear understanding of the person's usual activities of daily vision. Standard measures of visual acuity such as Snellen visual acuity, depth perception, contrast sensitivity and color charts are often not useful. Similarly, vision-targeted quality of life measures such as reading and driving may have limited utility. At the Exceptional Vision Service at Boston Medical Center we have adapted measures of vision-targeted quality of life for people with developmental delays and physical and intellectual disabilities.

This presentation will review common causes of vision loss for people with intellectual disability, and describe how these conditions present and impact vision-related quality of life over time. We will review our strategies for assessing visual function and its likely impact on quality of life, and make recommendations for caregivers and decision-makers regarding how to address suspected vision loss.

**A. Head Over Heels: Vision and Falls**

Presenter: Alexis G. Malkin, O.D., F.A.A.O.  
Clinical Assistant Professor of Optometry  
New England College of Optometry

Description: The incidence of falls and of fear of falling increases with age. Visual acuity is a key independent risk factor for falls and hip fractures in the elderly. This lecture will discuss the interaction between vision and falls. It will provide an in-depth discussion of the current trends in the population with vision impairment. This lecture will also provide ways to minimize fall risk in people with vision impairment. These interventions can include referrals to physical therapy, occupational therapy, and orientation and mobility training. Discussion will also include considerations for appropriate spectacle modalities (bifocal vs single vision) as well as issues in polypharmacy.

### **B. Vision's Influence on the Body and Movement**

Description: Understanding how the body moves requires understanding the rolls of the sensory and motor systems. When these systems are working together, with perfect accuracy and timing, a person can produce purposeful coordinated movement. When the sensory system has impairment, such as in vision, it will have a strong impact on the motor system. This is going to influence how a child learns to move, and how an adult learns to balance. In teaching and caring for an individual with a visual impairment it is important to understand the complexity of vision's role in development of posture, balance, and movement. This presentation will help you to understand how to guide someone through these challenges and set up activities to develop movement skills and compensate for a visual impairment.
